#### **PRESENTATIONS:** II.

- a. Mike Dodge, Middle School Principal, gave an update on the middle school soccer program. It is going to be a club sport. Burt Wachter will be the coach. Games will be held on six Saturdays, with each site hosting a day of games one time in the season. Orchard View's day to host is September 9, 2023.
- b. Earl Schaub, Custodial Supervisor, has been working with officials to determine best places for flashing beacon signs. They recommend a total of nine solar powered beacons throughout the District. The cost is approximately \$5,000 per beacon.
- c. Tom Hamilton, Assistant Superintendent/Curriculum Director, presented an A-91 for Edmentum Licenses for virtual students. This will cover all virtual students for the Innovative Learning Center and for Orchard View Personalized Learning Academy and 5 administrative licenses.
- d. Heather Lorenz-Babcock, Business Manager, presented an A-91 for classroom tables Cardinal Elementary. The classroom tables there are in disrepair. The quote has tables for all classrooms at Cardinal and has already been budgeted in ESSER for classroom seating.
- e. Earl Schaub, Custodial Supervisor, discussed some potential softball (and baseball) field upgrades. He has been busy getting quotes on backstops, stone dust, vegetation removal, and cement and/or bleachers. He will bring a little more info at the Regular Board Meeting on August 21, 2023 and then the Board can make a decision.
- f. Gretchen Beauleaux, Executive Services Assistant, shared some Schools of Choice data. She had a chart with the number of openings, number of students accepted, and number of students denied, broken down by buildings and by grade levels. She also went over current numbers of students with affidavits and with letters of release.
