- a. Heather Lorenz-Babcock provided the board with a Technology update/for the 2020/2021 school year. She stated the Technology Department received nearly 2000 work orders during the year with over 80% of them being resolved within 48 hours. She stated that the office staff at all of the buildings have been phenomenal throughout the year distributing and collecting Chrome books and helping to troubleshoot issues. She stated that Kim Bidwell was a great help in getting the cradle points installed and managing the software for them. Heather presented 3 separate purchases for the board to review for next school year, one was for district signage upgrades, another for new document cameras for teacher work stations and the third one being for new digital control units for our HVAC system allowing remote management of building temperatures.
