II. PRESENTATIONS:

- a. Heather MacDonald and E'lyse Benson provided the Board of Education with an update from Cardinal Elementary for the 2021/2022 school year. Mrs. MacDonald and Mrs. Benson highlighted the 2021/20222 school initiatives, which included the Tier 1 SEL programs, DLT and the shift to standards based grading. They provided a video showcasing their CNN (Cardinal News Network), a presentation for their Kindness Club with 109 active student participants, and the Peer to Peer program. The Principals explained the areas of professional development they have identified for next year and ended the presentation with a short video of student's testimonials for teacher appreciation.
- b. Brandy Carey Community Education Director began the Adult Education Program update by stating that the Adult Ed Program is currently staffed with 12 individuals vs.
 19 staff at the beginning of the school year. Brandy stated they are in the process of interviewing new leadership for the program and the new leader will determine what the staffing needs are moving forward.
- c. Brandy Carey stated there is a federal mandated Head Start wage increase and would like the board to approve.
- d. Brandy Carey provided an A-91 to purchase new flooring for three child care classrooms in the amount of \$22,280.85

III. DISCUSSION:

- a. Board Treasurer, Leslie Nelson stated that she attended the MAISD Budget Review Meeting via Zoom on April 26, 2022. She stated that the ISD Budget passed with a vote of 12 1. She stated that this was Dr. Severson's last meeting and he asked that all districts focus on the mental health of the students, staff and community in the future.
- b. Superintendent Nielsen proposed an idea to add a new administrative position Transportation/Maintenance Director to lay a foundation for the future. He explained that Mr. Timmer would retain his duties in overseeing energy and sinking fund responsibilities.

c. Mr. Nielsen explained that we will possibly have two teachers that will be recommended for nonrenewal at the end of the school year. Mr. Nielsen will keep the board updated on this matter.
