- a. One Good Thing Jim Nielsen
  - OVHS FIRST Robotics Mr. Wilson, Mrs. Wilson, and Mr. Rogers are the coaches of the Robotics Team at OVHS. The team and their coaches brought their robot that they built to the meeting and did a demo. Mr. Wilson shared that this is the first time Orchard View has had a team that entered into the State Competition. The team won a rookie all star award. There are twelve matches that you compete in and you are in a three team alliance when competing. The object of the competition is to pick up as many cones or cubes as possible. The first 15 seconds is autonomous. Ours was consistently autonomous. Driving the robot was a little more difficult than they thought it would be. They have 2 seniors that will be graduating. The Middle School has a team as well and the High School team is planning to partner with them. Financial sponsors would be very welcomed for the future.

### III. PRESENTATIONS:

- a. Earl Schaub and Jack Timmer gave a lighting update. The High School lighting is obsolete. No parts are available through any service providers that we've checked with. We could maybe do a section and then use those parts to support the old section, but that's a band aid and will only last for a while OR we could just redo the entire system. It could cost up to \$500,000. We will need wiring, switches, relays, components, control boxes, etc. So far, the other buildings are ok. This came about a few months ago when WIRTZ Electric couldn't get lighting in a part of the building that did not have lights. Zylstra has been good at getting us parts from other districts so far, but can no longer get them.
- b. Heather Lorenz-Babcock explained the budget amendments to the General Fund, Food Service, Student Activity, Community Education, and Technology Fun.
- c. Jim Nielsen talked about the Resolution for MAISD Biennial Election. The ISD has 2 Board seats open. One current board member has indicated a desire to run for another term. We will make a recommendation on who we support as our delegate. Board members should look over the Resolution and let us know if you have any questions.
- d. Heather Lorenz-Babcock discussed the need for travel software upgrade at Community Education. The travel database is outdated. In 15 months, their platform will no longer be supported. We need to update to a Cloud based software database. They'll take the records from our current database and upload them into the new system. This is no budget change. It comes from travel funds.
- e. Heather Lorenz-Babcock shared information regarding a Cybersecurity Software Purchase. Kyle and David have been looking at some security options. This will send some phishing e-mails to students and staff. There is also a PD component. It can be put on our website for the entire community to use. This would come from the tech and security funds.
