II. Cardinal Pride/Communications

- Samantha Wilson, HS Principal stated that they have secured a vehicle donor for the Ride with Pride initiative.

III. PRESENTATIONS:

- a. Director, Brandy Carey presented the board with the Community Education program highlights for the past school year. She acknowledged the Childcare program staff for stepping up to help remote learners participate in virtual school activities using laptops while at childcare. She outlined the facility upgrades that have taken place, along with the plan to add 3 community pickle-ball courts outdoors at the Community Education Center. She announced that drivers training classes will be offered to all Adult Education graduates free of charge. Brandy also takes great pride in the services being offered to our senior citizens and feels these services are of great value to the community.
