- A101 FIRST FLOOR AND CEILING PLANS (REISSUED)
 - a. Added wall type callout for window/door infill in exterior wall.
- 2. A141 FIRST FLOOR FINISH PLAN (REISSUED)
 - a. Revised WT-1 grout color and note added to provide cove tile base in Basis of Design.
 - b. Altered Interior Elevations to adjust height of wall tile. Added note to verify condition of CMU after tile demo and to provide additional courses of new tile to cover if required.
 - c. Added INPRO surface mount stainless steel 48" end wall protectors at existing openings between kitchen and serving area, to replace those removed during demo of wall tile.
 - d. Added note to join existing tile at jamb with appropriate tile trim at existing openings between kitchen and serving area. Existing tile to remain in jamb unless damaged.
- 3. A321 WALL SECTIONS AND DOOR DETAILS (REISSUED)
 - a. Revised height of OH coiling door in Door Schedule to 8'-0".
